

3. OBJECTS OF THE TRUST

6. POWER OF THE BOARD OF TRUSTEES:

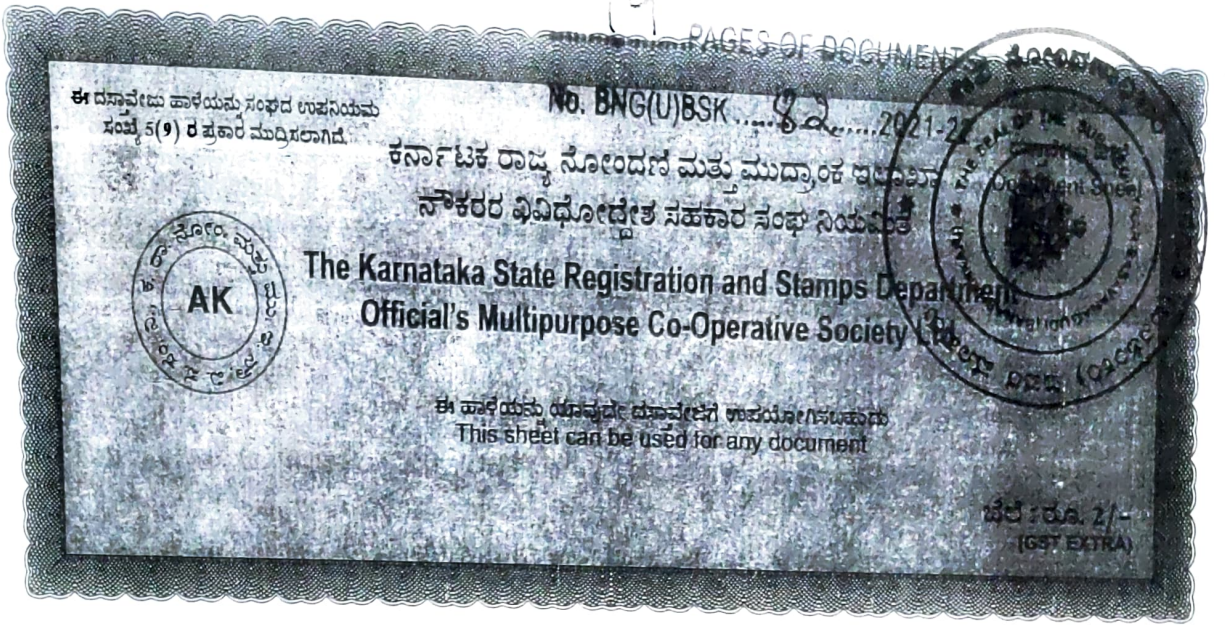

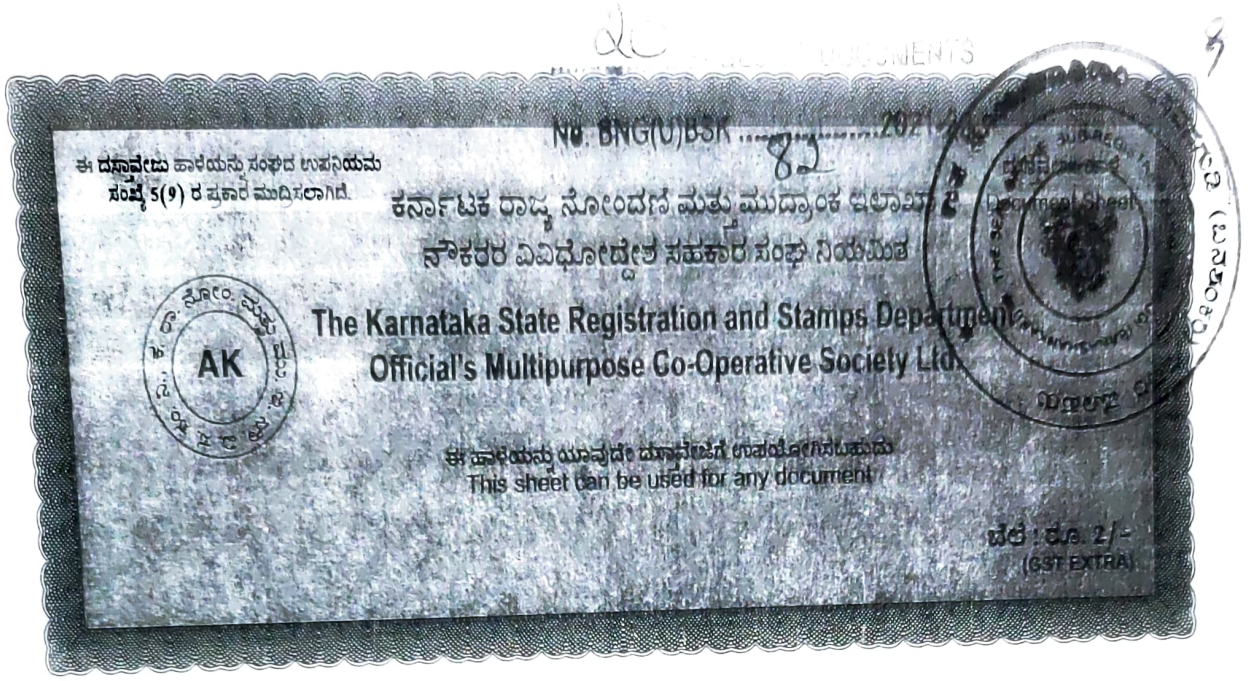




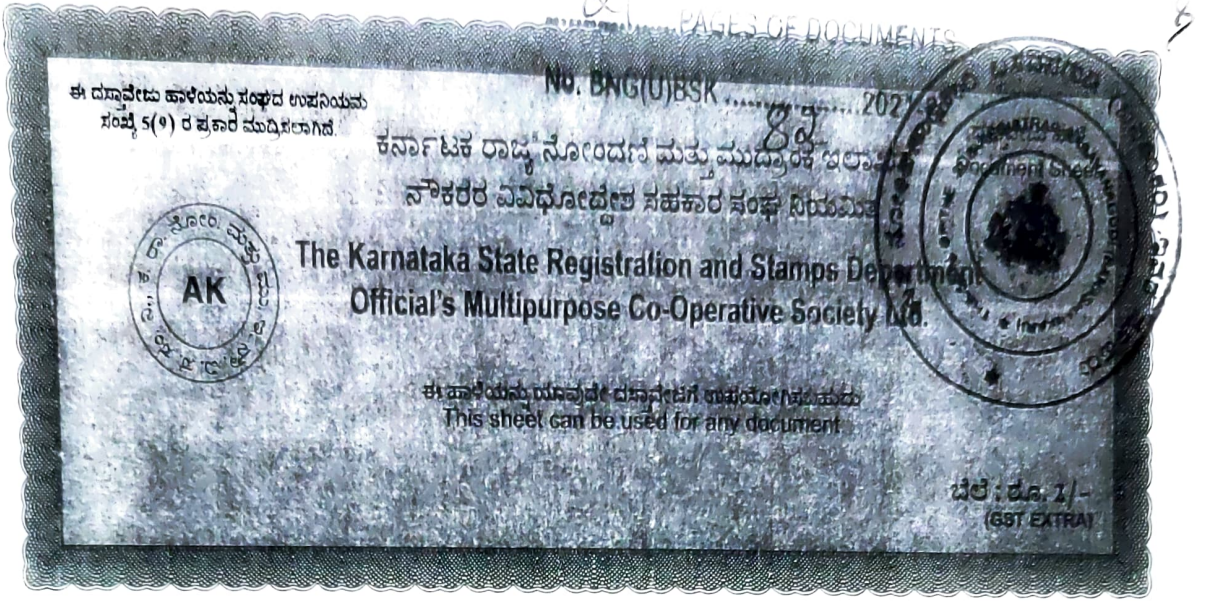
- d) To acquire on lease or by purchase or otherwise and to sell, mortgage, to lease out or transfer in any other manner, properties, movable or immovable and to construct buildings, manage and to deal with such properties and all other assets of the Trust and to pledge, hypothecate or otherwise create a lien over them to raise funds, and to deal generally with the assets for the purpose of achieving the objects of the Trust;
- e) To acquire land, construct such buildings, which yields money to maintain the institutions to fulfill the objectives of the Trust;
- f) To receive, collect, realize or cause collections, realisation of all interest, dividends, bonus or premium that accrues or becomes due on all or any of the stock, funds, securities, debentures or deeds or documents of like nature;
- g) To represent the Trust in all courts or before any other authorities and departments of Governments, Semi-Governments, local authority or any other statutory bodies in respect of Trust matters;

- h) To execute or negotiate all the necessary papers and documents whether negotiable or non-negotiable and to receive money or other assets and to grant receipts and discharge in respect thereof;
- i) To sign and verify all pleadings, memorandum of appeal, petitions and applications of all kinds of compromise and/or refer to arbitration, the whole or any part of the claim by or against the Trust and to engage lawyers or other professionals and to take all such other necessary steps;
- j) To borrow for the purpose of the Trust on personal credit of the Trust with or without charge or lien and responsibility upon the assets of the Trust;

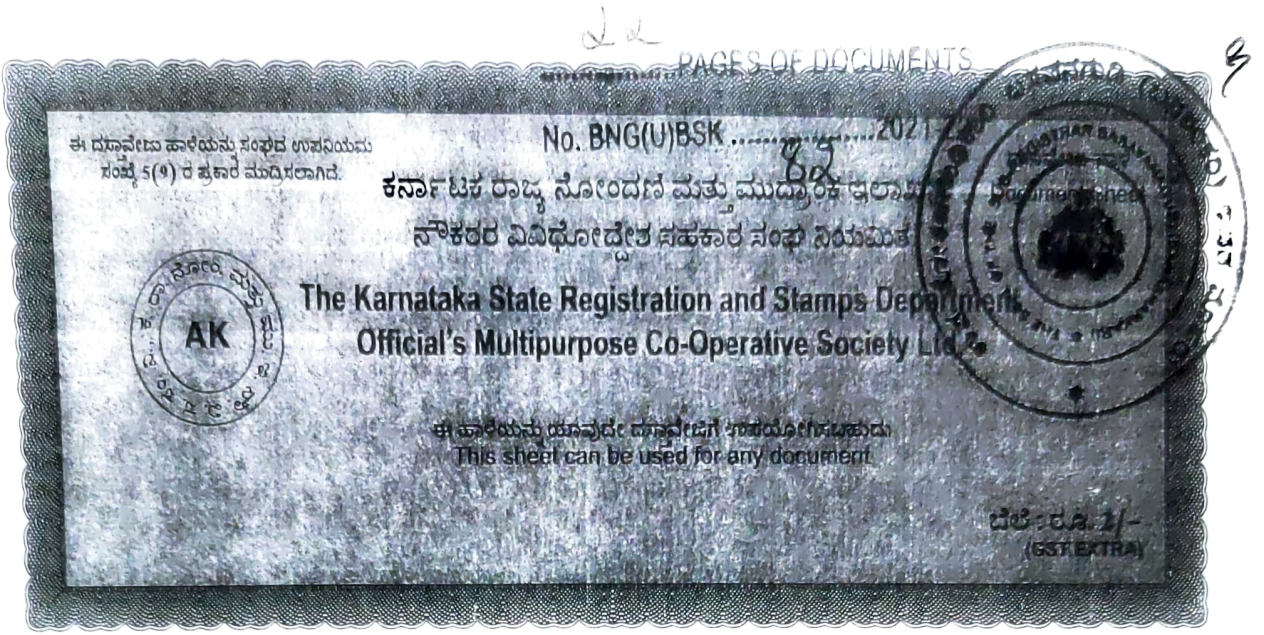

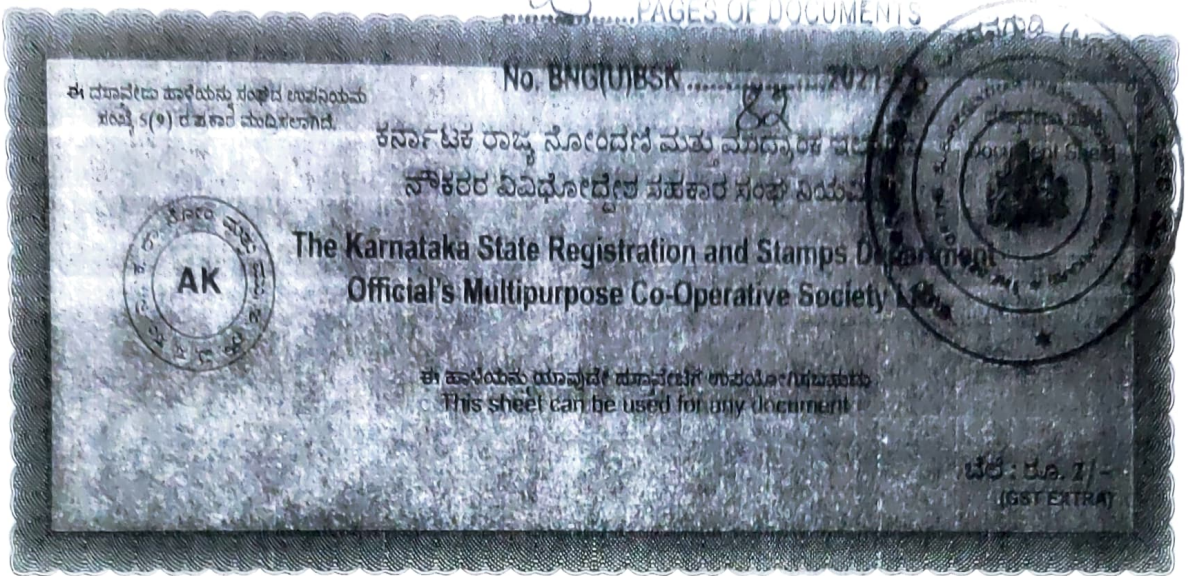

- p) The powers vested in the **BOARD OF TRUSTEES** shall be exercised according to the decision of the majority of the members of **BOARD OF TRUSTEES** and by way of resolution passed either by circulating or at the meeting of the **BOARD OF TRUSTEES**;
- q) To do all other acts, deeds, matters and things which may be deemed necessary and expedient for carrying out the objects of this Trust or its administration. The Chairman, Vice-Chairman, President, Vice-President, Treasurer or Secretary of the Trust shall have power to incur expenditure for running the administration of the office of the Trust in accordance with powers delegated to them;

7. CORPUS OF THE TRUST:

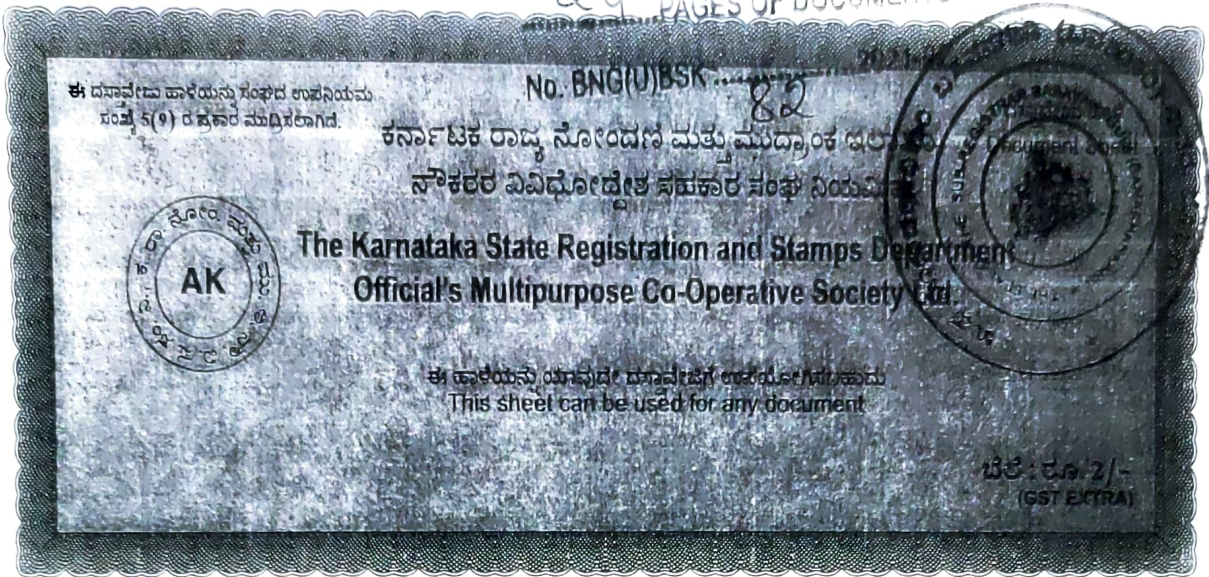

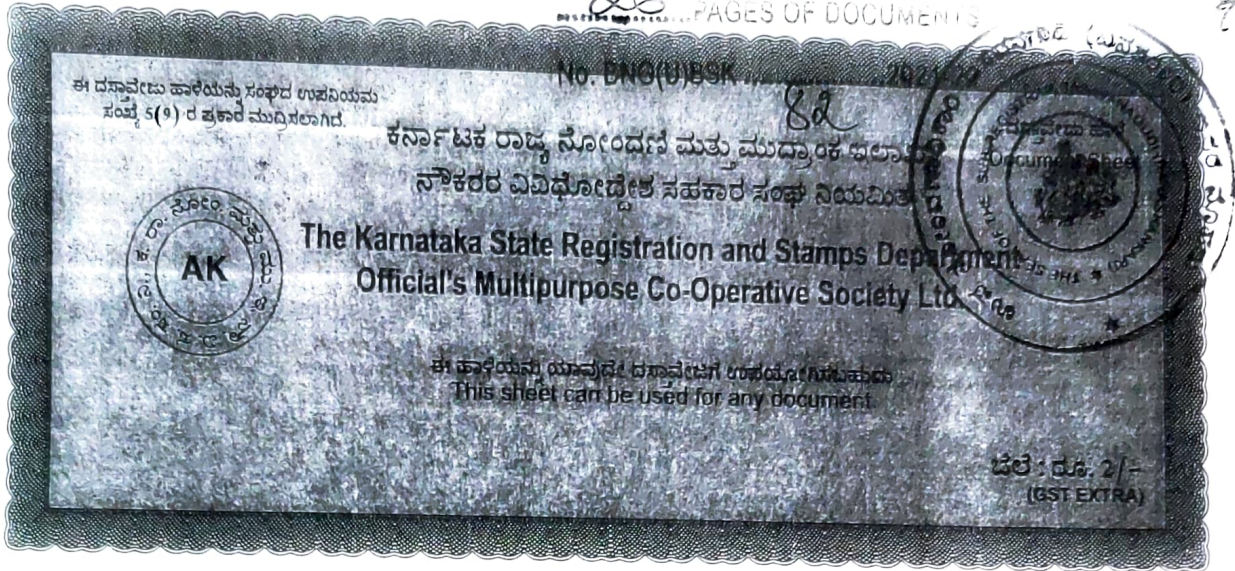
b. Notice of all meetings of the BOARD shall be sent to every member of the **BOARD OF TRUSTEES** either by electronic mail, post or otherwise and for this purpose the post communication/email addressed to the members of the BOARD OF TRUSTEES shall be deemed to be sufficient notice.
